On January 1, 2013, Holcim Philippines, Inc. (the "Company") executed a Share Purchase Agreement for the purchase by Trans-Asia Oil and Energy Development Corporation ("Trans-Asia") of the Company's 50% stake in Trans-Asia Power Generation Corporation ("TAPGC"). TAPGC is a joint venture between Trans-Asia and the Company. It owns and operates a 52 megawatt power plant in Norzagaray, Bulacan.
